The New UAE Insolvency Law - Where Are We Now?

New UAE Insolvency Law 3 Protective Composition Restructuring Plan Overview Debtor-led. Aims to assist a debtor in financial difficulty that is not yet insolvent. Debtor or Creditor led. Aims to assist a debtor to restructure its business (if possible) or declare bankruptcy and fairly liquidate any assets to fulfil the debtor's obligations.

The UAE government has been formally considering amendments to the insolvency regime since 2009, and a previous draft insolvency law was published in 2011 (the 2011 Draft); the New Law, however, is different in certain respects, as discussed below.

The general insolvency legal framework in the UAE is mainly set out in Book Five of Federal Law No. 18/1993 (the Commercial Transaction Law). In addition to the Commercial Transaction Law, certain provisions that are relevant to the UAE insolvency regime can be found in the UAE Federal Law No. 2/2015 (the Companies Law).

Principal current legislation to insolvency in UAE – The present insolvency framework is contained in the UAE Commercial Transaction Law (Federal Law no. 18 of 1993) . The UAE Commercial Companies Law (Federal Law no. 8 of 1994) which lays down the procedure for the dissolution of a company. The UAE Civil Code also provide for limited provisions covering individuals who became insolvent.
